Sumitomo Dainippon Pharma announces Organizational Realignment and Changes Related to Officers and Other Key Positions

Sumitomo Dainippon Pharma Co., Ltd. (Head Office: Osaka, Japan; President: Masayo Tada) today announced that it will accelerate further improvement of management efficiency and pursue vitalization of business structure and sustained growth in performance by making the following organizational realignment and changes related to its officers and other key positions, effective April 1, 2016:

I. Organizational Realignment (effective April 1, 2016)

Corporate Departments

- 1. Corporate Governance is created.*1
- 2. Corporate Communications is dissolved as a department. *1
- 3. General Affairs is dissolved as a department. *1
- 4. Global R&D Office is dissolved and its functions are transferred to Global Corporate Planning.*²
- 5. External Affairs is renamed (in Japanese language only).
- 6. Career Development is dissolved and its functions are transferred to Personnel.
- 7. Procurement is dissolved and its functions are transferred to Corporate Service Center and Manufacturing Management.
- *1 We are committed to continuously pursuing the establishment of a highly effective corporate governance system, aiming for fuller realization of our Corporate Mission and Management Mission. We seek to strengthen our corporate governance system by integrating the corporate governance-related functions of Global Corporate Planning and of Legal Affairs with the functions of Corporate Communications and of General Affairs. In this connection, the functions of General Affairs related to environment and safety are transferred to Corporate Service Center.
- *2 We seek to enhance the efficiency and strategic planning by transferring the functions relating to overall management of global R&D to Global Corporate Planning.

Sales & Marketing (Division)

- 1. Sub-divisions Higashi-Nippon Region and Nishi-Nippon Region are both dissolved and all the Region Management (Departments) under these sub-divisions are dissolved.*³
- 2. Tokyo Branch is created by integrating Tokyo Branch I and Tokyo Branch II.
- 3. Tokai Branch is created by integrating Shizuoka Branch and Nagoya Branch.

- 4. Keiji-Hokuriku Branch is created by integrating Hokuriku Branch and Keiji Branch.
- 5. Osaka Branch is created by integrating Osaka Branch I and Osaka Branch II.
- 6. Kyushu Branch is created by integrating Kyushu-kita Branch and Kyushu-minami Branch.
- *3 The region-based sub-division structure is terminated in a constructive posture and the strategy planning and other functions of the Region Management (Departments) are transferred to the respective branches, with a view to empowering the branches and strengthening the local market-focused approach in the sales and marketing activities through measures tailored to the local needs.
